

**PROPOSED AMENDMENT FOR D.LITT DEGREE OF KARNATAKA RAJYA DR. GANGUBAI HANGAL SANGEETHA
MATTU PRADARSHAKA KALEGALA VISHWAVIDYALAYA REGULATIONS, 2023.**

Preamble :

The Karnataka Rajya Dr. Gangubai Hangal Sangeetha Mattu Pradarshaka Kalegala Vishwavidyalaya, Mysore has been established on 15.09.2009 to provide high level teaching, training and research in Music and Performing Arts. The letters were addressed to the Government for running the different courses in Music and Performing Arts for according permission and the same was approved by the government Vide its Order Number : ED 274 URC 2010, Bangalore, Dated : 13.01.2011.

<p>THE FOLLOWING SHALL BE ELIGIBLE TO APPLY FOR THE DEGREE.</p> <p>1. Candidates who have studied in music, dance, drama and other performing arts and other interdisciplinary subjects or Achievements like Performances, Awards / honours (Government, Semi Government, Organizations, Trust-Societies etc.) Books and Articles in the concerned/allied/relevant discipline are eligible to apply for the D.Litt Degree. And candidates should have published or unpublished adequate quantity of work done independently in the form of research articles or books. Further, candidate should have crossed 40 years age prior to submission of application. Such candidates are eligible to submit their application along with their 10 copies of synopsis of the proposed work.</p> <p>1. The Registrar (Evaluation) shall refer the application along with the enclosed documents / works / research paper/ synopsis to the Committee consisting of all the Deans of Faculties for its opinion.</p> <p>This committee shall decide/recommend the work done by the candidate for further consideration in the specific BOS.</p>	<p>Changed</p>	<p>THE FOLLOWING SHALL BE ELIGIBLE TO APPLY FOR THE DEGREE.</p> <p>1. Candidates who have studied in music, dance, drama and other performing arts and other interdisciplinary subjects are eligible for applying for the D.litt Degree. candidates should be able to work independently and should have published more than ten research articles or books. Such candidates can submit their consistent research work in their respective fields with their application.</p> <p>2. In the D.Litt degrees candidates have to appear for the entrance exam containing 100 marks, oral examination contains 100 marks, presentation of lecture contains 100 marks Total 300 marks. To pass every exam minimum 55% (GM) and 50%) (SC/ST) to be obtained.</p> <p>3. If the Evaluation committee gives positive reports based on the marks, the Registrar Evaluation will submit the report recommended by the Committee to the Vice Chancellor for approval.</p> <p>4. Synopsis of the candidates who have passed the entrance examination will be scrutinized by the three members expert committee. The University will accept the recommendation made by the expert committee.</p>

5. There after candidates should have to submit their proposals to the Doctoral committee consisting of high level experts. If the said committee approves the research proposal, such candidate will be considered for registration after obtaining the orders of the Vice-Chancellor.

6. Candidate has to make research work for two years and submit the research progress report for every six months to the Registrar Evaluation on payment of prescribed fees. Thesis should be submitted within five years from the date of registration. The candidate is required to submit the report about that the thesis is of the original Research Work of the Candidate.

7. To evaluate the thesis submitted by the candidates a committee consisting of twelve experts will be constituted. The Vice-Chancellor will select three scholars among the said experts and the thesis will be sent for evaluation.

8. The three members of the Evaluation Committee should submit individual evaluation report to The Chairman/Registrar (Evaluation), Board of studies. If the Research Thesis is rejected from any one of the Evaluators, it will be consented from the Fourth evaluator. Fourth evaluator. Among the three evaluators if any evaluator reject the thesis, candidate will have a chance to resubmit with payment of prescribed fees after verification.

2. If the BOS approves the research proposal, such candidate will be considered for registration for D.Litt degree of this university after obtaining the approval of the Vice-Chancellor.

3. After successful registration, the Candidate shall submit the Thesis of his/her original work done independently, after the six month from the date of the registration to the Registrar Evaluation on payment of prescribed fees.

4. Thesis shall be submitted after the six months of period or maximum of five years from the date of registration. Once the maximum period is expired the candidate shall required make a fresh application for the registration.

5. Further processing of thesis evaluation, the said Board(s) of Studies shall suggest a panel of 5 names of suitable Examiners. The panel of Examination shall consist of Scholars of high repute in the subjects / area concerned either from within or outside the country or both. The panel of Examination shall be sent to the Registrar (Evaluation) by the chairman, Board of studies.

9. Among the three evaluators any one of the evaluator advised to modify the thesis and then the thesis will be sent to the same evaluator for evaluation after modification by observing the formalities.

10. Whenever the University Invites the candidates he/she should have come to the university and give a lecture on the Research thesis. Oral exam also will be held in the presence of the experts. This is also a part of Evaluation.

2. The Board of studies in the Faculties concerned shall select out of this panel, three examiners by the Vice Chancellor to whom, the Thesis submitted shall be referred for evaluation and specific opinion on the academic merit of the thesis and their suitability for the award of the degree.

- a) Thesis evaluation report should reach the Registrar Evaluation by name by the Evaluator within 45 days from the dated of report of the Thesis.
- b) If any delay in sending report before the last date University shall send the thesis to the next Evaluation on priority respectively.

Among the three examiners one shall be nominated as co-ordinator by the Vice-Chancellor.

11. On the basis of eligibility criteria maximum five candidates are permitted for admissions every year under faculty wise.

12. D.litt degree registration Fee Rs.20000/- (GM), RS.10,000/- (SC/ST) as entrance fee to be paid in the form of D.D. In favour of **Finance Officer, KSGH Music and Performing Arts University, Mysore. Issued by State Bank of Mysore.** Submit the D.D to The Registrar Evaluation and get registered.

13. Candidates once fees paid will not be returned, Any Changes in this fee structure from time to time will be intimated by the University to the candidate.

3. (a) The report of the three examiners shall be collected separately by the Registrar(Evaluation) and put together for referral to the Co-ordinator nominated by the Vice-Chancellor.

(b) if any two of the Examiners reject the Thesis submitted, it shall be sent to the 4th examiner. If the 4th examiner also reject then this shall be rejected.

Viva-voce shall be conducted with the help of the Chairman Board of Studies of the concerned discipline / Co-ordinator. The said Viva-Voce Board shall allow the candidates an opportunity to defend his/her Thesis in the light of critical points or questions raised by different examiners.

4. The Chairman Board of Studies of the concerned discipline / Co-ordinator shall after such Viva-Voce examination forward to the Registrar (Evaluation) a consolidated report along with the report on the Viva-Voce and individual examiners reports.

5. The Registrar (Evaluation) thereupon shall submit the report for the consideration of the Syndicate/Vice-chancellor. The reports shall be considered by the Syndicate or by the Vice-Chancellor as authorized by the syndicate and results declared accordingly and this decision shall be final.

Two copies of the published work shall be submitted to the university library. After the award of the D-Litt degree, the thesis or any publication derived from the thesis work shall be the property of the university.
